Please ensure you provide the correct spelling and jersey number for the team manager, coaches, and all players for the program and tournament tee shirts. Thank you.
- 5. Contact one of the local hotels to reserve rooms for your team (see page 6 for a list of nearby lodging options.
- 6. Please ensure you bring the following: District/State Tournament Official Affidavit, with the Tournament Player Verification Forms, correct amount, and type of proofs of residency, waivers, medical releases and Tournament Pitching record or a letter from Southeastern Region with permission to advance without tournament play. You must provide any Charter Committee waivers that the team has received from Little League Baseball and Softball® or Southeastern Region. All uniforms must have a Little League patch correctly affixed to the jersey.
- Please make sure all team equipment is legal and in good repair. Bats <u>must not</u> have any fractures, dents, or flat spots and must be a Little League authorized bat that meets USA Baseball (USABat) performance standards. <u>All unauthorized or damaged equipment will be removed and held by District 15 staff until the team departs the tournament.</u>

Schedule of Events

Team Registration, Opening Ceremony, and Pre-Tournament Meeting will be held at Virginia Credit Union Stadium, home of the Fredericksburg Nationals (FredNats). The Fredericksburg Nationals are a Minor League Baseball team that is the Single-A affiliate of the Washington Nationals. The Stadium's Concession Stand will be open with a scaled down menu for purchase, but alcohol will not be served. The park is a cashless venue so please plan accordingly. Based on the number of teams entered, we anticipate Pool Play on Friday, Saturday, and Sunday with Single Elimination for the top two (2) teams in each pool advancing to the Elimination Bracket starting on Monday, 21 July with the Championship Game on Tuesday, 22 July. Schedule and Tournament Format is subject to change based on the number of teams entered, field availability, and potential weather delays.

Team Registration

All teams must register with the Tournament Officials at the Virginia Credit Union Stadium between 1:00 and 4:00 pm on Thursday, July 17, 2025. Please contact the Virginia District 15 DA, Jim Roberts, if you cannot register during this time.

Please be prepared to present the following items:

- Your team's up-to-date tournament eligibility affidavit signed and approved by your League President and District Administrator. The affidavits will be reviewed, approved, and returned by the Tournament Director prior to your team playing their first game in the tournament. All managers and coaches must have proof of current (NFHS) Concussion Training Certification in the Notebook along with the Diamond Leader Certificate.
- Two (2) copies of the medical release form for each player on your roster. One should be with the player verification form in the notebook and a set should be retained by the team manager throughout the tournament in case of a medical emergency.
- Each team is responsible for making lodging arrangements. Participating leagues/teams are responsible

Note: Each team MUST have their approved tournament eligibility affidavit to participate in the tournament. Please take the time to review it before traveling to the tournament site and ensure all necessary documentation is included. This includes **Diamond Leader Training and** Concussion Awareness Training Certification from the NFHS for all Managers and Coaches. Your team will not be permitted to register, practice or participate in the tournament without a valid, signed, and approved affidavit. No Exceptions.

for making hotel reservations and for any damage that occurs to rooms or other hotel property. If damage occurs to a room during the team's stay, the league/team/individual party is responsible for making restitution with the hotel.

- Team roster form (included in this packet) with names of all players and <u>official</u> coaching staff (Manager and up to two (2) coaches) as they would like to be announced. Please include player jersey numbers and double check the spelling of all players' names. The roster information will be used to customize the souvenir tee shirts.
- Your District Championship Banner.
- A welcome packet/goody bag will be provided for each player.

Opening Ceremony

The Opening Ceremony will be held at the Virginia Credit Union Stadium. In case of inclement weather, the opening ceremony will still be held at the stadium as there is ample space and dry seating. The Opening Ceremony is scheduled to begin promptly at 5:30 pm with team introductions. Team Managers are requested to have their teams in jerseys or appropriate tee shirts, shorts or jeans/slacks, and sneakers lined up and ready to be introduced by 5:15 pm. Additional details will be provided at check in. Team uniforms are not required or expected. Please ensure you have your District Championship Banner to display as your team is introduced. Team pictures may be taken. The teams will line up and parade onto the field and line up around the infield. The concession stand will be open with a limited menu of food and beverages for purchase.

Following the Opening Ceremony, all tournament participants are encouraged to enjoy the facility and participate in traditional Pin Trading with fellow competitors.

Pre-Tournament Meeting

A mandatory meeting for all managers, coaches, tournament officials, and umpires will be held at **7:00 pm** in the designated room at the Virginia Credit Union Stadium following the opening ceremony. It is expected that this time will be used for participants to meet other teams and players and exchange commemorative pins.

We will review the tournament rules as well as the expectations and logistics of play: warm-up schedule, pre-game announcements, substitution process, etc.

All 2025 Little League Baseball Tournament rules will be enforced and adhered to <u>without</u> exception. Please ensure all equipment brought to the tournament site meets Little League regulations and specifications. <u>Any equipment removed from the tournament will not be</u> <u>returned to the respective team until after their last game in the tournament</u>. Neither the Tournament Director nor Umpires in Chief have the authority to waive any rule without the express permission and approval of the Tournament Committee in Williamsport. All managers, coaches, players, and fans are encouraged to review the Tournament playing rules and Little League safety rules before they arrive to help prevent any surprises or misunderstandings. All managers and coaches are reminded to ensure they have completed NFHS Concussion Awareness Training within the last year and the certificate is included in the Affidavit Notebook.



Tournament Playing and Practice Fields

All Tournament Games and Practices will be held at the Caroline County Little League Complex:

All games will be played at the Caroline County Little League Field. The Concession Stand will be open and there is ample parking. Bleacher seating is available, and lawn chairs are welcome. Playing fields are multi-purpose and feature skinned infields, grass outfields, and permanent pitcher mounds.

Practice fields and batting cages are available at the tournament site. Team Managers will be permitted to reserve a practice field/batting cage when registering the team. No smoking or tobacco use is permitted at or near the playing fields, which includes vaping and chewing. Smoking is permitted in the parking area(s). No alcohol or illicit drugs shall be brought to the tournament site. Pets are not allowed at the field. We strongly recommend you leave your pets at home.

Admission and Parking Fees

There will not be any admission charges or parking fees during the Little League Baseball Tournament. However, we do "pass the hat" during each game and ask tournament spectators and fans to donate what they can, in cash, to help defray tournament expenses. Thank you.

Spectator Policies and Procedures

Bleacher seating is available, and lawn chairs are welcome.

No noise makers of any kind may be used during tournament games; this includes cowbells, whistles, boat horns, etc. Special announcements or "walk up" songs by fans are not permitted.

Individuals wishing to record or live stream games for personal use are not permitted to affix any equipment to the playing facility, including but not limited to fencing, dugouts, stanchions, or light poles. If fans wish to stream a game, it must be viewed through a personal social media account for private use only and may not be on the open internet.

No smoking or tobacco use is permitted at the field or on school grounds, which includes vaping and chewing. No alcohol or illicit drugs shall be brought to the tournament site. Pets are not allowed at the field at any time.

Tournament Game Procedures and Guidelines

The tournament Format will be Pool Play with 16 teams participating. The pools were drawn randomly at the Virginia State Little League Association Meeting on Saturday, 22 March 2025. There will be four (4) pools with four (4) teams in each pool. Each team will play the other teams in the same pool, with games on Friday, Saturday, and Sunday, 18 through 20 July. The top two (2) teams from each pool will advance to the Championship Single Elimination Bracket, which will be played on Monday and Tuesday, 21 and 22 July. All games shall be conducted in accordance with the 2025 Little League Baseball® Tournament Rules and Guidelines.

Teams should plan to arrive at the field at least 75 minutes prior to game time and should report immediately to the Tournament Director. Team managers will present the team's affidavit (only) with the pitching record to the Tournament Director. The managers will declare ineligible pitchers for the game about to be played. If not already done, a coin toss will decide the home and visiting teams. The team that has traveled the farthest will call the toss. The winner will choose home or visitor. The Home team will occupy the first base dugout; visitors will occupy the third base dugout. No exceptions.

Teams will have 10 minutes of infield practice prior to each game (as time permits). A **rostered** coach or manager must be present before any player can take batting practice, infield practice, or can occupy the dugout. Batting helmets must be worn when conducting batting practice. Nonrostered adults or children may **not** enter the dugout, the batting cage, **or** the playing field at any time before or during games. During the games and when warming up pitchers or conducting infield practice, catchers must wear an approved catcher's mask with a dangling throat protector.

When time allows, each team will be announced 10 minutes prior to every game, with the visiting team being announced first. Announcements will be followed by the National Anthem or the Little League Pledge. The plate conference with managers, umpires, and the Tournament Director will follow. Coaches and players shall remain in the dugout until the plate conference is concluded and the UIC instructs the defensive team to take the field. Base coaches may take their positions when directed by the UIC after the "throw down" to second base.

Every substitution, position change, etc., **<u>must</u>** be made from inside the field by the manager to the official scorer while accompanied by the umpire-in-chief. Once a change is announced, it is official. The manager is <u>**always**</u> 100% responsible for ensuring the change is proper and legal. The manager is also responsible for ensuring that mandatory play is met by all rostered players present at the game site.

After the game is over, be sure the pitchers' pitch counts are properly recorded in your affidavit and acknowledged by the manager, official scorer, and the Tournament Director. Once you leave the field, the affidavits may not be changed. It is good practice to announce ineligible pitchers at the coin toss and Plate Conference.

Concession and Vendor Information

Each team is expected to provide food and beverages for their players, managers, and coaches throughout the tournament. Coolers may be brought to the tournament site, but grilling or open fires are not permitted at any time at the park. Food concessions will be available throughout the tournament and the Concession Stand accepts cash and/or debit/credit cards as payment. The current Concession Menu is provided below for your information planning.



Internet Information

Game results will be reported, and tournament brackets will be updated and posted at the tournament site and will be available on the Virginia District 15 website,

www.VADistrict15.org. There is no plan for games to be streamed via Game Changer, Facebook, or other internet media by the host. If fans wish to stream a game, it must be viewed through a personal social media account for private use only and may not be on the open internet. If individuals wish to record or stream the game, the device may not be attached to any part of the field, including fences, backstop, dugout, light poles, etc. The recording device must be free standing (or held) and may not be in the vicinity of the Press Box/Scorer's Table.

Team Equipment

Each team must provide their own equipment. District 15 and CCLL will aid in case of emergency. Please inspect your equipment before traveling. In accordance with Little League Baseball® rules, **the team manager is responsible for ensuring the players are properly equipped and all equipment meets Little League® standards, rules, and regulations. Tournament officials will not be inspecting equipment prior to the first game or any game.** Managers are encouraged to inspect all equipment prior to reporting to the tournament site to ensure it is authorized and safe. Some items to look for include but are not limited to:

- Helmets must be NOCSAE-approved and cannot be modified.
 - Altering a helmet in any way (drilling holes, removing padding, etc.) may cause a manufacturer to void the NOCSAE certification of that helmet, making it illegal (and unsafe) for use in Little League play. If you have altered your helmet or intend to, please contact the helmet manufacturer to determine if altering the helmet will void the NOCSAE certification.
 - Little League International issued a letter to all youth batting helmet manufacturers for clarification on whether adding C-flaps to their helmets voids their NOCSAE certification. Manufacturer responses are posted on Little League International's website, <u>www.LittleLeague.org/HelmetAdditions</u>, where you can find more information about helmet attachments as it becomes available.
 - Tournament officials will not be checking helmets to ensure they are safe and have not been altered. It is the team manager's responsibility to ensure all equipment is safe and ensure the manufacturer's warranty has not been voided.
- Catcher's masks must be NOCSAE-approved and must have a dangling throat protector. This includes hockey-style masks. If the throat protector does not dangle when the mask is turned to face the ground, it is not a dangling throat protector.
- Bats must be baseball bats which meet the USA Baseball Bat standard (USABat) as adopted by Little League. Non-wood bats for this division shall bear the USA Baseball logo signifying the bat meets the USABat USA Baseball's Youth Bat Performance standard. ALL BPF 1.15 bats are prohibited. Additional information is available at www.LittleLeague.org/BatInfo.

Equipment that is damaged or not permitted will be removed from the dugout and will be held by the District 15 Staff until your team departs from the Tournament. Please leave non-Little League conforming equipment at home.
